**JOINT RESOLUTION OF THE CITY OF DELAVAN AND THE TOWN OF DELAVAN
TO ESTABLISH MAINTENANCE RESPONSIBILITY FOR CERTAIN PORTIONS OF MARSH ROAD,
MOUND ROAD, BORG ROAD, AND NORTH SHORE DRIVE**

WHEREAS parts of the northeasterly and southeasterly limits of the City of Delavan lie adjacent to the boundaries of the Town of Delavan; and

WHEREAS certain annexations from the Town of Delavan into the City of Delavan have occurred, extending said northeasterly and southeasterly limits of the City of Delavan, which extend substantially along the Town of Delavan roads known as Marsh Road and Mound Road between County Highway "F" and State Highway "11", as well as along Borg Road between Delavan Landings Lane and North Shore Drive; and

WHEREAS the City of Delavan and the Town of Delavan desire to clarify their respective duties, obligations and responsibilities with respect to the ordinary and regular maintenance of said sections of Marsh Road, Mound Road, Borg Road and North Shore Drive;

NOW, THEREFORE, IT IS HEREBY RESOLVED by and between the City of Delavan and the Town of Delavan that with respect to Marsh Road between State Highway "11" and County Highway "F", the Town of Delavan shall maintain said road and that said maintenance shall include patching signage, snow removal, patching, paint striping, tree/brush trimming and removal, mowing, or other improvement repairs; up to but not including repaving or reconstruction improvements;

BE IT ALSO RESOLVED by and between the City of Delavan and the Town of Delavan that with respect to Mound Road between State Highway "11" and County Highway "F", the City of Delavan shall maintain said road and that said maintenance shall include signage, snow removal, paint striping, tree/brush trimming and removal, mowing, patching or other improvement repairs; up to but not including full repaving or reconstruction improvements;

BE IT ALSO RESOLVED by and between the City of Delavan and the Town of Delavan that with respect to Borg Road between Blue Heron Drive and North Shore Drive, the Town of Delavan shall maintain said road and that said maintenance shall include signage, snow removal, paint striping, tree/brush trimming and removal, mowing, patching or other improvement repairs; up to but not including full repaving or reconstruction improvements;

BE IT ALSO RESOLVED by and between the City of Delavan and the Town of Delavan that with respect to North Shore Drive between Borg Road and Rucker Road, the Town of Delavan shall maintain said road and that said maintenance shall include signage, snow removal, paint striping, tree/brush trimming and removal, mowing, patching or other improvement repairs; up to but not including full repaving or reconstruction improvements;

IT IS LASTLY RESOLVED that this Resolution is subject to further review and modification at the request of either party regarding the maintenance responsibilities along these roadway segments.
