**Special Event Permit Cost Recovery Agreement**

I do hereby understand and agree that as an Applicant, I will be responsible for all normal fees payable by the Applicant in connection with the issuance of a special event permit. I further understand and agree to be responsible for any additional or consequential costs to the Town of Delavan as a result of my event, including but not limited to fire, police or there professional services, which are deemed necessary for public safety and welfare in connection with my event. All fees not paid at the time of application shall be paid within thirty days of invoicing. If payment is not made, said fees and costs may be assessed against any real property I own in the Town as a special charge or otherwise recovered as breach of contract as the law may allow.
