**A RESOLUTION APPROPRIATING AND LEVYING THE
NECESSARY FUNDS FOR THE OPERATION OF THE
GOVERNMENT AND ADMINISTRATION OF
THE TOWN OF DELAVAN FOR THE FISCAL YEAR 2021**

WHEREAS, the Electors of the Town of Delavan, Walworth County, Wisconsin, having received notice of the Public Budget Hearing and meeting in special session, together with the Town Board of Supervisors, do ordain and approve the following funds for the operation of the government and the administration of the Town of Delavan for the fiscal year 2021:

General Government:	\$	625,094
Public Safety:	\$	2,383,545
Public Works:	\$	878,697
Culture, Recreation & Education:	\$	153,920
Conservation & Development:	\$	91,620
Debt Service:	\$	1,092,500
Capital Improvements	\$	<u>2,000,000</u>
TOTAL:	\$	7,225,376

FURTHER, BE IT HEREBY RESOLVED:


1. That there is hereby levied a tax of \$3,609,958.00 upon all of the taxable property within the Town of Delavan, Walworth County, Wisconsin as returned by the Town Assessor, for the uses and purposes set forth in said budget; and
2. That the Town of Delavan Clerk is hereby authorized and directed to spread said tax upon the current Tax Roll to the Town of Delavan, Walworth County, Wisconsin.


